#### HB1 -Governor - An Act making appropriations for FY2014

Sponsor: Governor Cosponsors: No Cosponsors

Summary: The Governor's proposed budget for the FY 2014 fiscal year features \$32,272,894,287 in direct

appropriations, \$484,181,928 in agency chargebacks, and \$553,668,595 in retained revenue, for a total of \$33,310,744,810 in direct spending. An additional \$2,252,874,057 in federal grants and \$1,998,429,771 in consolidated transfers brings the total appropriations up to \$37,562,048,638. Finally, \$10,626,744,331 of non-appropriated (or "off budget") trust spending, increases the total for fiscal year expenditures to \$48,188,792,969. The Governor also proposes substantial tax changes to support "critical investments," by raising the income tax rate to a uniform 6.25%; doubling the personal income exemption amounts; repealing numerous specific personal income tax expenditures; lowering the sales/use tax rate to 4.5%; and extending the sales tax to computer and data processing services and custom software; indexing the gas tax; Taxing security and utility corporations like other business corporations; repealing the FAS 109 deduction; capping the film tax credit at \$40 million per fiscal year; repealing the exemption of candy and soda from the sales tax; and increasing the cigarette excise by \$1 to \$3.51 per pack. The Governor also proposes to establish a "Commonwealth Public Infrastructure Fund" to expend sales tax revenues exclusively for financing public

infrastructure

This bill is notable for its more restrained approach to transportation finance as opposed to the Governors bill: while the Governor sought to raise \$19.2 billion in revenues, mostly supported by bonding and revenue enhancements floated in his HB 1 submission, this bill seeks to close the gap by increasing the gasoline tax by 3 from 21 to 24 per gallon; by increasing excise taxes on other tobacco products by substantial amounts; by eliminating the utility tax classification; by changing the sourcing of sales for multi-state corporations; by modernizing the tax code with respect to software and software services, including modifications to software and computer system planning and design; by requiring utilities with infrastructure on state rights-of-way to pay fair market value for their use; by redirect a 2.5 underground storage tank gas tax to the Commonwealth Transportation Fund, and indexing it to inflation; by requiring transportation and MBTA officials to issue a request for proposals for licensing the naming rights to subway, bus, and commuter rail stations; and by raising approximately \$85 million in additional funds for transportation by 2018 through various measures.
