

Happy early Fall/late Summer! We hope the conclusion to the boating season goes smoothly and successfully. It was a pleasure to see so many of you at the MMTA member social last week.

MMTA's Government Relations efforts prioritize matters which are uniquely important to the Business of Boating, although we partner periodically with other organizations on matters of general and major business impact. On behalf of MMTA we monitor hundreds of bills during each legislative session. The full tracking list is available at www.boatma.com in the Members Only section, with all 5000+ bills analyzed. As usual, it is updated constantly, as the legislature schedules hearings and information develops, with monthly postings on the MMTA website and periodic ENEWS briefs for members. Below is one particular matter - the **Ocean**

Management Plan - which is of unique importance to the Business of Boating because if it changes unfavorably, whole marinas could see their customer base evaporate as non-boating uses took up what used to be open water. The proposed revisions to the Areas of Concentrated Recreational Boating are pictured and are available by clicking 'Read More' below.

Even though these proposed revisions are beneficial to recreational boating interests, it's important that the State is aware of just how many people this plan impacts. **Below is a sample comment letter we hope you might consider submitting to the state before November 25 on behalf of**

Dear Office of Coastal Zone Management:

As members of the Massachusetts Marine Trades Association we spent a great deal of time providing recreation boating data and verifying and correcting those Areas of Concentrated Recreational Boating over the past many years. We support the results published in this draft and ask that you don't reduce these recreational boating areas. They are reasonably accurate and inclusive. If anything, they leave out boated areas and should not be reduced.

Recreational boating is important to the Commonwealth of Massachusetts. It is our right, held in trust by the Governor, to navigate the state's waterways. As the Ocean Management Plan evolves over time, areas of recreational boating activity should be provided the necessary protections due to this long-existing protected trust right to navigate.

Islands - October 22, 5:00 p.m.-7:00 p.m. at the Katharine Cornell Theater, 54 Spring Street, Vineyard Haven, MA 02568.

Boston and South Shore - October 27, 5:30 p.m.-7:30 p.m. at the Executive Office for Energy and Environmental Affairs, 100 Cambridge Street, 2nd Floor Rooms C-D, Boston, MA 02114.
